Digitally Recorded Video

- Recorded video can be stored for a month or more and can be archived by event on a CD or tape

Local Onsite Viewing

- Do uninterrupted work from the comfort of your business office and see what events are going on

Remote Offsite Viewing

- From any remote location that has Internet access or a standard telephone line view each camera at your business real time or digitally review past recorded events by date and time
- Systems are available that do not require a computer for remote viewing
- Up to 1000 viewers may view simultaneously with our browser based internet server systems
